Tamil Nadu with admission intake capacity of 100 seats for Undergraduate (BHMS) course and for PG course with 25 seats in 05 subjects namely Homoeopathic Materia Medica with 05 seats, Organon of Medicine with 05 seats, Repertory with 05 seats, Practice of Medicine with 05 seats and Paediatrics with 05 seats for academic year 2024- 25- reg.

White Memorial Homoeopathic Medical College, Attoor, Veeyanoor-629177. Dist.Kanyakumari. Tamil Nadu has submitted an application for permission for sanction of 100 seats for Undergraduate (BHMS) course and for PG course with 25 seats in 05 subjects namely Homoeopathic Materia Medica with 05 seats, Organon of Medicine with 05 seats, Repertory with 05 seats, Practice of Medicine with 05 seats and Paediatrics with 05 seats for the academic year 23-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

- Teaching faculty: 57 fulltime faculty list is submitted in Part-1 for UG and PG including PG guide list faculties.
- a) In the PG Department of Pediatrics- there is no higher faculty available as he has been promoted to professor but is now appointed as a guest teacher.
- Guest Faculty and Consultants of Modern Medicine with name in attendance and acquittance role shall be provided.
- Hospital facilities:-
- Case records are not submitted against the direction issued from MARB. IPD and OPD case records
 (copy of one OP and one IP cases of 1st and last day of every month for last one year) shall be
 submitted for verification.
- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- OPD/IFD Case sheets shall be mallitained with complete case lastory, analysis and evaluation and repertorisation and and made available in medical record room for academic purpose of students and for follow up attendance of the patients.
- Diet register, USG is submitted but x-ray register is not submitted.

- Lab investigation report should be maintained properly in case records.
- Miscelleneouis:-AEBAS shall be enabled within period of 30 days.
- · Financial details:-
- a) 14 teachers' form -16 is not from the traces portal.
- b) 08 teachers form -16 not submitted.

All the shortfalls observed in your College shall be rectified within a period of 30 days or before counselling initiates, whichever earlier and compliance report shall be submitted to the MARB. failing which the conditional permission issued will be cancelled without further notice.

Considering the above observations, and facilities available, MARB has decided to issue conditional permission to White Memorial Homoeopathic Medical College, Attoor, Veeyanoor- 629177. Dist.Kanyakumari. Tamil Nadu with admission intake capacity of 100 seats for Undergraduate (BHMS) course and for PG course with 25 seats in 05 subjects namely Homoeopathic Materia Medica with 05 seats, Organon of Medicine with 05 seats, Repertory with 05 seats, Practice of Medicine with 05 seats and Paediatrics with 05 seats for academic year 2024- 25.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHM5 course shall be usated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by Medical Assessment and Rating Board.
